In 1938, Ed leased the former Hamilton & Young Shirt Factory building on Mill Street from Rae Fuller Randlett and operated as The Blue Moon featuring dancing and roller skating into the early 1940s. The building was later leased by Rae to Frank Allen, Jr in 1947 who operated it as Skateland until the late 1950s. Ed was the founder of Unity Raceway in 1948 and operated it until 1960. He also owned and operated Riverside Ballroom in Portland for many years. Marion married 1st to John Wilcox in 1929 and married 3rd to Wallace Audet in 1950.
